## **Publications and guidance**

Title: Searching, screening and confiscation at school

### Description:

Guidance explaining the powers schools have to screen and search pupils, and to confiscate items they find.

This guidance is for:

- school leaders
- school staff
- governing bodies
- local authorities

#### It applies to:

- local-authority-maintained schools
- academies and free schools
- pupil referral units (these provide education for children who can't go to a mainstream school)
- non-maintained special schools (for children with special educational needs that the Secretary of State for Education has approved under section 342 of the Education Act 1996)

The guidance covers:

- powers to search without consent
- prohibited items schools can search for
- powers to confiscate items found during searches

#### Title: Approaches to preventing and tacking bullying

#### **Description:**

Qualitative research to understand anti-bullying practices schools have found effective. These Include approaches to tackling bullying generally and more specific types of bullying, for example:

- racial bullying
- special educational needs and disability (SEND) bullying
- lesbian, gay, bisexual or transgender (LGBT) bullying

The report contains common themes found throughout the research and 7 case studies. It's intended to be used as a resource by schools and other stakeholders looking for examples of anti-bullying practices

The reducing teacher workload action plan sets out the steps the DfE will be taking following the findings from the <u>teacher workload survey 2016</u>. The DfE developed the protocol in response to the

2014 workload challenge survey. It sets out the DfE commitment to:

- introduce minimum lead-in times (the times schools have to prepare for the changes they need to make) for significant changes to accountability, the curriculum or qualifications
- do more to consider the workload of staff in schools when introducing such changes

It will help with managing staffing and employment issues, and making decisions. It replaces the statutory guidance from 2009, 'Guidance on managing staff in schools'

'Regulated activity in relation to children: scope' describes work that a <u>barred person</u> must not do. We have also published guidance on 'Disqualification under the Childcare Act 2006'
